KCCU is proud to give back to the communities that we live in and serve by supporting the following charitable programs:

- Annual Coat Drive KCCU collected over 435 coats as well as other cold weather gear and donated them to local community organizations to distribute.
- Shred Day KCCU hosted a Community Shred Day at five branch locations.
- Holiday Toy Drives KCCU staff and members donated 498 toys for children in need in our community through The Salvation Army Angel Tree, There's Enough, and St. Joseph County United Way.
- **Essential Goods Drive** KCCU held an essential goods drive to collect much needed items for local shelters. KCCU also donated a total of \$2,500 to five local homeless shelters.
- **Charitable Food Drive** KCCU collected food donations and donated \$500 to the South Michigan Food Bank, serving southern counties of Michigan, and \$500 to Feeding America West Michigan, which serves the Western and Northern counties of Michigan.
- **Teacher Grants** Fifteen teachers were selected to each receive \$400 to purchase classroom supplies, totaling \$6,000 going back to local classrooms.
- **Scholarships** Ten students were each selected to receive \$1,000 to be applied to their Fall 2023 tuition expenses.

KCCU also provided support and donations to many other local charities and non-profit service organizations in 2023 such as Battle Creek Homeless Shelter, Cheff Center, Exodus Place, Humane Society of South-Central Michigan, Wounded Warriors, Bronson Children's Hospital, Gryphon Place, First Day Shoe Fund, and many more.
